In-Person Learning Information

Classroom Capacity

All classrooms will be at a reduced capacity.

- Standard-sized classrooms can accommodate approximately 14 students maintaining six (6) feet of physical distance between desks or workspaces.
- Performing Arts, Kinetic Wellness, and other learning spaces' capacity varies according to the size of the space.
- Classrooms will be designed to accommodate six (6) feet of space between students' desks, tables, or other workspaces.

In-Person Schedule

Based on the survey results, CFHS will be open for In-Person Learning four (4) days each week

- Group A students will attend classes in-person on the campus Mondays and Tuesdays and through CFSDConnect (live) on Wednesdays and Thursdays.
- Group B students will attend classes in person on the campus Wednesdays and Thursdays and through CFSDConnect (live) on Mondays and Tuesdays.
- Group R students will attend Monday - Thursday through CFSDConnect (live).
- All students will attend remotely on Fridays through CFSDOnline.

<p>Instructional Environment</p>	<p>Teachers will teach one lesson for all learners (in-person and remote) at the same time.</p> <ul style="list-style-type: none"> Four days of instruction with in-person and remote learners through CFSDConnect (live) Asynchronous lessons on Fridays <p>The in-person learning experience will differ from the pre-COVID learning experience (i.e., physically-distanced teacher interactions with students, physically-distanced student interactions with other students).</p>																																																																		
<p>Schedule Changes</p>	<p>It is a priority at CFHS to keep students with their same teachers and current schedule. If it is not possible, some schedule changes may occur.</p>																																																																		
<p>Technology</p>	<p>Students are expected to bring a laptop or tablet (personal or school-owned) with a charger each day to limit the sharing of devices and to maintain access to Google Classroom. CFHS has Chromebooks that students can check out for the year, if needed. Students are responsible for their own devices.</p>																																																																		
<p>Mitigation Strategies</p>	<ul style="list-style-type: none"> Face masks required (must be worn over nose and mouth; no valves, vents or gaiters) Physical distancing Improved air circulation Regular hand washing & hand sanitizing Daily campus cleaning & sanitizing High use areas cleaned throughout the day Personal school supplies carried in student's backpack Protocols on the use of shared devices, materials and equipment Home health screening (temperature and other symptom check) Outdoor eating in shaded areas Isolation procedure for COVID concerns No parents or visitors on campus See the CFSD Mitigation Plan for more information.

Remote Learning Information

<p>Remote Learning Schedule</p>	<p>We will no longer operate on a 2-day synchronous (live) and 3-day asynchronous learning schedule. Each class has a daily live, synchronous lesson except on Fridays. There may be exceptions during a short-week schedule.</p> <ul style="list-style-type: none"> ● We will continue to follow the current bell schedule for the remainder of the semester. ● Students are expected to log in to each of their classes at the designated time. ● Students are expected to remain logged into their class until dismissed by the teacher. <ul style="list-style-type: none"> ○ Students may be dismissed prior to the end of the period for independent work or other work that does not require them to be attending the live classroom stream.
<p>Remote Learning Environment</p>	<p>Teachers will utilize a camera and an integrated technology system that will enable all students to access the same lesson at the time the lesson is delivered.</p>
<p>On-Site Supervision (SOS@CFSD)</p>	<p>Available to families who have attended in the past.</p>

Moving Between Learning Environments

<p>What will my response to the survey bind my student to?</p>	<p>If your initial choice is for Remote Learning, your decision is binding for the remainder of the first semester. For the second semester, your student may request In-Person Learning. The request may be granted if space becomes available. Transition to In-Person Learning will be dependent upon capacity in all of your student's classes. Students will be placed on a waitlist if space is not available.</p> <p>If your initial choice is for In-Person Learning, you may transition to Remote Learning during the remainder of the first semester.</p>
<p>Can students move back and forth between In-Person and Remote?</p>	<p>Based on health, safety, scheduling, and capacity, we will be limiting movement back-and-forth between the options. Students may move once from Remote to In-Person Learning (if space is available) or In-Person to Remote Learning during the remainder of the first semester. If a student requests a second move, the case will be reviewed and the request may not be granted.</p>
